**NOTE: Take Home Exams Listed Below****Constitutional and Civil Rights - Reuben - 4 Hour Take Home**

Exam can be taken any day between Wednesday, May 2 in Week 1 and Tuesday, May 8 in Week 2.

**Criminal Law §2 -F. Bowman - 8 Hour Take-Home**This exam to be taken on *Tuesday, May 8 ONLY*
