

## Logistical information

### ASCL Annual Meeting and Works in Progress Conference October 17-19, 2019

The ASCL Annual meeting and Works in Progress (WIP) conference will be held at the [University of Missouri School of Law](#), home of the nationally-renowned [Center for the Study of Dispute Resolution](#).

We are located in Columbia, Missouri, which is approximately two hours from both the Kansas City (MCI) and St. Louis (STL) airports. If you fly into one of those airports, you will need to rent a car or arrange for express coach/bus transport via [Mo-X](#). Alternatively, you can fly into the Columbia/Jefferson City regional airport (rather small and sometimes inconvenient as to timing) and arrange for a taxi, Uber or rental car from that location. American Airlines and United Airlines serve [Columbia Regional Airport](#) (COU).

Directions and parking information for the University of Missouri School of Law are available at <http://law.missouri.edu/about/directions/>. If you are parking on campus, you will need to arrange for your own parking pass; instructions can be found via the preceding link. However, many hotels are within walking distance of the law school.

A map of campus, including nearby parking lots, is available online (<http://mu-cf-map.col.missouri.edu/muparking/>). The law school building, Hulston Hall, is located on Missouri Avenue between Conley Avenue and Rollins Street. Some events will be held at the Memorial Union, which is on Hitt Street between University Avenue and Rollins Street, and which is only a few minutes' walk away from the law school.

Although we are not able to assist with lodging arrangements or costs, we have arranged for several hotels to hold a block of rooms for meeting attendees. Depending on demand, these rooms may fill quickly. However, there are many other hotels in town, and many will be entirely suitable with respect to cost and location.

Please note that if you decide to catch a flight out of St Louis or Kansas City that is early in the morning, you may prefer to book a room near the airport from which you are leaving rather than staying in Columbia the preceding night, just for your own comfort.
