**Other Items (including take-home exams with special timing):**

1. All students in **LRW** will have a final memo (worth 60% of the semester grade) due Nov. 19.

2. **Elder Law** (English) students will be assigned a group project. It is distributed during the last week of class and students must hand it in by 2 p.m. on Dec. 17, the last day of exams.

3. **Federal Courts** (Lietzan) will have a take-home exam. Students will receive it at the start of the exam period, beginning at 8:00 a.m. on Tuesday, Dec. 7, and it will be due on the last day of the exam schedule Friday, Dec. 17 by 4:00 PM

4. **Administrative Law** (Reuben) The final will be a traditional four-hour take home exam that you may take on any day beginning the first Wednesday of exams, Dec. 8, and the second Wednesday of exams, Dec. 15. The exam is to be picked up in Room 203 any time after 8:30 a.m. and must be turned in no later than 4 p.m. that day. Therefore, if you want the full four hours, you will need to pick it up no later than noon.

5. **Partnership Tax** (Barondes) will have a take-home exam. It will be available to students starting at 9 a.m. on Monday, Dec. 13, in the second week of the exam period, and ending at 4 p.m. on Friday, Dec. 17, at the end of the exam period.
