Learning Outcomes:

Through this course, students will:

- Understand and be able to analyze the principal purposes of and justifications for criminal law:
- Understand and be able to analyze foundational criminal law doctrine, including the act requirement, *mens rea*, causation, and defenses;
- Understand and be able to apply the statutory elements of core crimes, and be able to
 identify key distinctions among definitions for these crimes at common law and in the
 Model Penal Code;
- Gain knowledge that will be tested on the Criminal Law portion of the bar exam;
- Understand key critiques of the criminal legal system.

Grading:

Grading will be based on a timed final examination (85%) and class participation (15%). The final exam will consist of multiple choice and essay questions. The multiple choice portion will be closed book and during the essay portion you are permitted to use your notes and casebook.

• Be present, engaged, prepared, and on time for class;

- Volunteer to answer questions I ask the class;
- Demonstrate preparedness when you are called on;
- Ask thoughtful, well-informed questions;
- Listen actively to anyone who is speaking;
- Contribute meaningfully to class discussion;
- Interact respectfully and considerately with me and your classmates.
